Fiscal Year 2013: House and Senate Budget Comparison Brief

On May 25, 2012, the Senate approved its fiscal year (FY) 2013 budget after three days of debate. The Senate budget proposes \$12.61 billion in funding to support MassHealth and other health-related programs for low- and moderate-income residents, including \$15.2 million added during Senate budget debate. This total represents an increase of 5.8 percent over FY 2012 spending; when additional spending expected to occur in FY 2012 is taken into account the Senate increase is 4.1 percent, compared to the House increase of 4.5 percent. The budget now goes to a legislative Conference Committee that will reconcile the differences between the House and Senate FY 2013 budget proposals.

How the House and Senate FY 2013 Budget Proposals Compare

Like the House's FY 2013 budget, the Senate's spending plan relies on a set of savings strategies similar to those proposed by the Governor in January (see http://www.massbudget.org/reports/pdf/FY2013H2_BudgetBrief_v6.pdf) and both budgets

also include funding sufficient to cover expected enrollment growth in the Commonwealth Care program (the cost of this program will be lower than originally projected, due to plan procurement efforts that yielded a 5 percent decline in average per-enrollee costs). However, the Senate budget also includes an additional set of savings, as well as a variety of policy changes adopted during Senate budget debate. While the two budgets are broadly similar, there are a number of issues that the Conference Committee appointed to resolve the differences between the two budgets will need to address. The remainder of this Budget Brief outlines these differences and notes some of the key points of agreement between the two budgets. Following are two tables, one which includes only those line items where there are differences in the amounts proposed. Line items where both the House and the Senate included the same amounts are not included here. For a full set of all line items, see Appendix. The other table includes differences in the outside sections of the budget proposals.

Aside from the differences outlined above, the House and Senate propose to fund other MassHealth and health reform programs at virtually identical levels, and the two budgets share a number of provisions:

- Language maintaining FY 2012 rates for a medical respite program for the homeless at McInnis house, at a cost of \$3 million (House language is in 4000-0300; Senate language is in 4000-0500); not included in House 2.
- Authorizations for funds from the administrative line item to be spent for the Office of Health Equity; not included in House 2.
- A requirement that HHS contract for a study of MassHealth children with complex care needs, including an analysis of how their needs can best be served in keeping with goals of medical home model (no appropriation); not included in House 2.
- Transfer of \$186.9 million from the General Fund to a new Delivery System Transformation Initiatives Trust Fund that will provide incentive payments to providers to improve health delivery and payment systems. Funding for such payments is also included in a pending FY 2012 supplemental budget.
